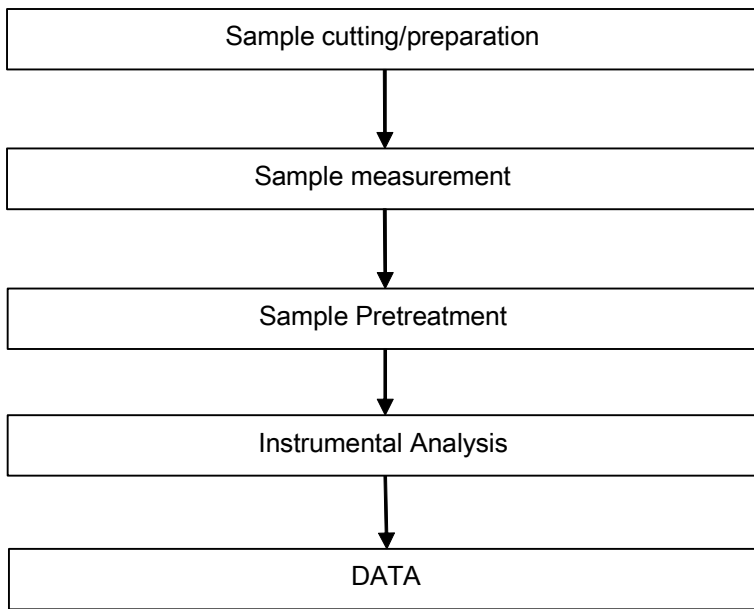

SVHC Testing Flow Chart

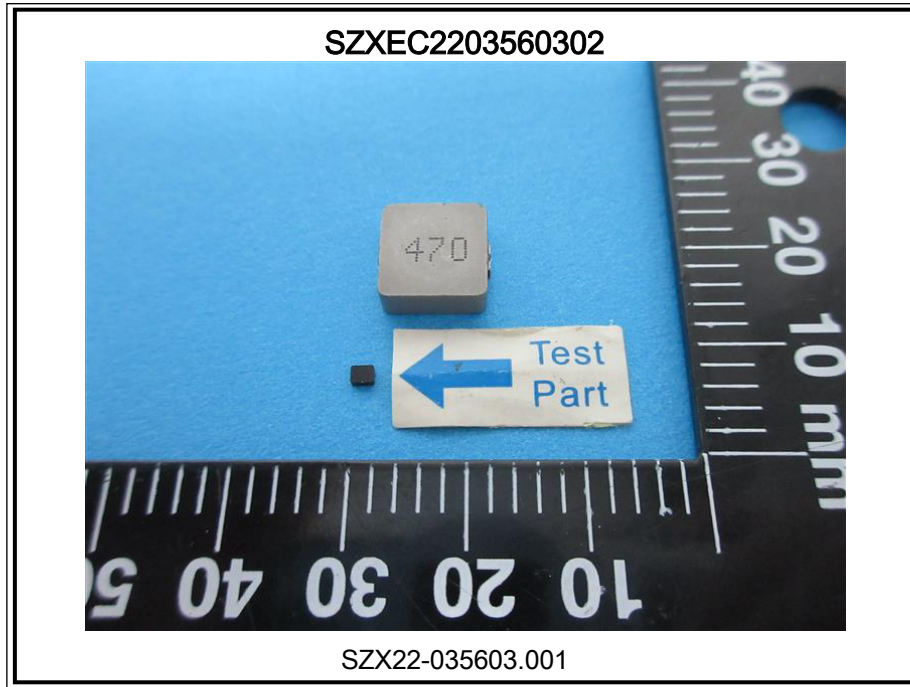
